TAARIFA KUHUSU MAPATO NA MATUMIZI YA MAPATO YA NDANI YA HALMASHAURI KWA KIPINDI CHA MWEZI JULAI HADI SEPTEMBER 2021 IKIWA NI ROBO YA KWANZA YA MWAKA WA FEDHA 2021/22

1.0 UTANGULIZI

Ofisi ya Rais - TAMISEMI inautaratibu wa kutoa Taarifa ya Mapato na Matumizi ya Fedha za Mapato ya Ndani kila robo mwaka ili kuongeza uwazi na uwajibikaji katika ukusanyaji wa mapato ya ndani ya Halmashauri Nchini. Taarifa hii ni ya robo ya kwanza ya mwaka wa fedha 2021/22 (Kipindi cha Julai hadi Septemba 2021). Aidha, taarifa hii imeandaliwa kwa kutumia Mfumo wa Ulipaji Serikalini (MUSE).

Taarifa hii inaainisha ufanisi wa kila Halmashauri katika ukusanyaji wa mapato ya ndani kwa kulinganisha makisio yaliyoidhinishwa na kupitishwa na Bunge la Jamhuri ya Muungano wa Tanzania. Uchambuzi wa matokeo umeandaliwa kwa kulinganisha aina za Halmashauri katika makundi na Kimkoa. Kadhalika, taarifa hii inaonyesha mwenendo wa matumizi ya mapato ya ndani kwa kuainisha matumizi ya Halmashauri kwenye miradi ya maendeleo kwa kuzingatia **asilimia 40 au 60** na **asilimia kumi 10** ya mapato ya ndani kwa ajili ya mikopo ya Wanawake, Vijana na Watu wenyewe Ulemavu.

2.0 MWENENDO WA UKUSANYAJI WA MAPATO YA NDANI

Kwa mwaka wa fedha 2021/22 Halmashauri zote za Wilaya, Miji, Manispaa na Maji zilipanga kukusanya **Shilingi Bilioni 863.9** kutoka kwenye vyanzo vyake vya ndani. Aidha, katika kipindi cha mwezi Julai hadi Septemba, 2021 Halmashauri zimekusanya jumla ya **Shilingi Bilioni 212.7** ambayo ni sawa na **asilimia 25** ya makisio ya mwaka sawa na **asilimia 100** ya lengo la robo mwaka. Uchambuzi wa taarifa kuhusu ufanisi wa Halmashauri katika ukusanyaji wa mapato ya ndani, unaonyesha kuwa Halmashauri **5** zimekusanya kwa **asilimia 50** au zaidi ya lengo la Mwaka, Halmashauri **47** zimekusanya kati ya **asilimia 30 hadi 49**, Halmashauri **92** zimekusanya kati ya **asilimia 20 hadi 29**, Halmashauri **37** zimekusanya kati ya **asilimia 10 hadi 19**, na Halmashauri **3** zimekusanya **chini ya asilimia 10**, hii ni kwa kuzingatia lengo la Mwaka. Ulinganisho

wa ufanisi wa ukusanyaji wa mapato ya ndani unaonyesha kuwa Halmashauri ya Wilaya ya **Hanang** imeongoza katika Halmashauri zote **184** kwa kukusanya **asilimia 66** ya makisio yake ya mwaka, ikifuatiwa na Halmashauri za Wilaya za **Mlele, Ngara** na **Meatu** ambazo zimekusanya **asilimia 51** ya lengo la Mwaka. Hata hivyo, sababu ya Halmashauri hizi kufanya vizuri zaidi katika robo ya kwanza ya mwaka ni kwamba baadhi yao kipindi kizuri cha makusanyo ya mapato ya ndani ni miezi ya Julai hadi Septemba 2021. Aidha, Halmashauri ya **Wilaya ya Tandahimba** imekuwa ya mwisho kwa kukusanya **asilimia 3** ikifuatiwa na Halmashauri ya **Mji Nanyamba asilimia 6** na Halmashauri ya **Wilaya ya Newala asilimia 8**. Sababu ya Halmashauri hizi kuwa na makusanyo ya chini katika robo ya kwanza ya mwaka ni kwamba Halmashauri za Kanda ya Kusini zinategemea zaidi zao la Korosho ambapo msimu wake ni kati ya mwezi Oktoba hadi Disemba. (*Kiambatisho Na. 1A*).

Katika kuzipima Halmashauri zote kwa kigezo cha wingi wa mapato (pato ghafi), Halmashauri ya **Jiji la Dar es Salaam** imekusanya mapato mengi zaidi kuliko Halmashauri zote kwa kukusanya **Shilingi Bilioni 17.8** ikifuatiwa na Halmashauri ya **Manispaa ya Kinondoni Shilingi Bilioni 9.9** na Halmashauri ya **Manispaa ya Temeke Shilingi Bilioni 9.4**. Aidha Halmashauri **6** kati ya **184** zimekusanya kuanzia **Shilingi Bilioni 5** na zaidi (*Kiambatisho Na. 1B*).

Aidha, **Mkoa wa Manyara** umeongoza kwa kukusanya **asilimia 40** ya lengo la Mwaka, ikifuatiwa na **Mkoa wa Simiyu asilimia 35**, **Mkoa wa Kagera na Songwe asilimia 31** na **Mkoa wa Mtwara** umekua wa mwisho kwa kukusanya **asilimia 12** ukifatiwa na **Mkoa wa Dodoma asilimia 18** na **Mkoa wa Lindi asilimia 20** (*Kiambatisho Na. 2*).

2.1 TAARIFA YA MAPATO YA NDANI YA HALMASHAURI KWA KUZINGATIA AINA YA HALMASHAURI

2.1.1 HALMASHAURI ZA MAJIJI - Kundi hili linajumuisha Halmashauri 6

Kwa kipindi cha robo ya kwanza ya Mwaka wa fedha 2021/22 **Halmashauri ya Jiji la Arusha** imeongoza kwa kukusanya mapato kwa **asilimia 27** ya makisio yake ya mwaka ikifuatiwa na Halmashauri ya **Jiji la Dar es Salaam kwa asilimia 26** na **Halmashauri ya Jiji la Tanga kwa asilimia 25**. Aidha **Halmashauri ya Jiji la Dodoma** imekuwa ya mwisho katika kundi hili ambapo imekusanya **asilimia 16** ya makisio yake ya mwaka ikifuatiwa na Halmashauri ya **Jiji la Mbeya asilimia 21** na **Jiji la Mwanza asilimia 24** (*Kiambatisho Na. 3A*).

2.1.2 HALMASHAURI ZA MANISPAA - Kundi hili linajumuisha Halmashauri 20

Kwa kipindi cha robo ya kwanza ya Mwaka wa fedha 2021/22 **Halmashauri ya Manispaa ya Kahama** imeongoza kwa kukusanya mapato kwa **asilimia 34** ya makisio yake ya mwaka ikifuatiwa na Halmashauri za **Manispaa ya Bukoba asilimia 32** na **Manispaa ya Mpanda asilimia 29**. Katika kundi hili **Halmashauri ya Manispaa ya Mtwara** imekuwa ya mwisho ambapo imekusanya **asilimia 15** ya makisio yake ya mwaka ikifuatiwa na Halmashauri za **Manispaa za Morogoro asilimia 17** na **Ubungo asilimia 18** . (*Kiambatisho Na. 3B*).

2.1.3 HALMASHAURI ZA MIJI - Kundi hili linajumuisha Halmashauri 21

Kwa kipindi cha robo ya kwanza ya Mwaka wa fedha 2021/22 **Halmashauri ya Mji wa Mbulu** imeongoza kwa kukusanya **asilimia 44** ya makisio yake ya mwaka ikifuatiwa na Halmashauri za **Miji ya Kibaha asilimia 43** na **Tunduma asilimia 39**. Aidha, **Halmashauri ya Mji wa Nanyamba** imekuwa ya mwisho kwa kukusanya **asilimia 6** ya makisio yake ya mwaka ikifuatiwa na Halmashauri za Miji za **Newala asilimia 11** na **Halmashauri ya Mji Masasi asilimia 14** (*Kiambatisho Na. 3C*).

2.1.4 HALMASHAURI ZA WILAYA - Kundi hili linajumuisha Halmashauri za Wilaya 137

Kwa kipindi cha robo ya kwanza ya Mwaka wa fedha 2021/22 **Halmashauri ya Wilaya ya Hanang** imeongoza kwa kukusanya **asilimia 66** ya makisio yake ya mwaka ikifuatiwa na Halmashauri za Wilaya za **Mlele, Ngara, Meatu** kwa **asilimia 51**. Aidha, **Halmashauri ya Wilaya ya Tandahimba** imekua ya mwisho katika kundi hili kwa kukusanya **asilimia 3** ya makisio yake ya mwaka ikifuatiwa na **Halmashauri ya Wilaya ya Newala kwa kukusanya asilimia 8** ya makisio yake ya mwaka (*Kiambatisho Na. 3D*).

3.0 MATUMIZI YA MAPATO YA NDANI

3.1 MATUMIZI KATIKA MIRADI YA MAENDELEO

Uchambuzi wa taarifa za matumizi ya fedha za mapato ya ndani kwa kipindi cha kuanzia Julai hadi Septemba 2021 ikiwa ni robo ya kwanza ya Mwaka wa fedha 2021/22 unaonesha kuwa Halmashauri zimetumia **Shilingi Bilioni 47.8** sawa na **asilimia 61** ya fedha zilizopaswa kutumika kwenye miradi ya maendeleo kwa robo ya kwanza ambayo ni **Shilingi Bilioni 78.8** ambazo ni **asilimia 40** kwa **Halmashauri zenye Mapato yasiyolindwa yasiyozidi Shilingi Bilioni 5 au asilimia 60** ya mapato yalisiyolindwa kwa Halmashauri zenye Mapato yanayozidi Shilingi Bilioni 5. Aidha, **Shilingi Bilioni 165.7** zimekusanya kwa kipindi cha Julai hadi Septemba 2021 ikiwa ni mapato yasiyolindwa. Halmashauri **14** zimetumia **asilimia 100** au zaidi ya kiasi

kilichopaswa kutumika, Halmashauri **76** zimetumia kati ya **asilimia 50** na **99** ya kiasi kilichopaswa kutumika, Halmashauri **94** zimetumia chini ya **asilimia 50** ya kiasi kilichopaswa kutumika. Aidha taarifa zinaonesha kuwa Halmashauri ya **Wilaya ya Songwe** imeongoza kwa kuchangia **asilimia 190** ikifuatiwa na Halmashauri za **Wilaya za Wanging'ombe asilimia 140** na Halmashauri ya **Wilaya ya Rufiji asilimia 136** Aidha, Halmashauri ya **Wilaya ya Simanjiro** imekua ya mwisho kwa kuchangia **asilimia 1** ikifuatiwa na **Halmashauri za Wilaya za Sikonge asilimia 2, Mkinga asilimia 6 na Halmashauri 9** hazikutumia kiasi chochote cha fedha kwenye miradi ya maendeleo. Halmashauri hizo ni Halmashauri za **Wilaya za Kondo, Uvinza, Gairo, Tandahimba, Newala, Misungwi, Itigi, Korogwe na Bumbuli** (*Kiambatisho Na. 4*).

3.2 MIKOPO YA VIKUNDI VYA WANAWAKE, VIJANA NA WATU WENYE ULEMAVU

Uchambuzi wa taarifa za matumizi ya fedha za mapato ya ndani kwa kipindi cha kuanzia mwezi Julai hadi Septemba 2021 ikiwa ni robo ya kwanza ya mwaka wa fedha 2021/22 unaonesha kuwa Halmashauri zimechangia kiasi cha **Shilingi Bilioni 7.3** kwenda kwenye Vikundi vya Wanawake, Vijana na Watu Wenye Ulemavu ikiwa ni **asilimia 44** ya kiasi kilichopaswa kuchangiwa kwenye robo ya kwanza ambayo ni **Shilingi Bilioni 16.6** kutokana na **asilimia 10** ya mapato halisi ya vyanzo visivyoindwa kilichokusanywa katika kipindi hicho. Halmashauri **16** zimechangia **asilimia 100** au Zaidi, Halmashauri **54** zimechangia kati ya **asilimia 50 na 99** na Halmashauri **38** zimechangia chini ya **asilimia 50** kwenye mikopo ya Wanawake, Vijana na Watu wenye ulemavu. Aidha, Halmashauri **76** hazikuchangia kiasi chochote kwenye Mfuko huu. Taarifa zinaonesha kuwa Halmashauri ya **Wilaya ya Mji wa Nanyamba na Halmashauri ya Wilaya ya Msalala** zimeongoza kwa kuchangia **asilimia 185** ikifuatiwa na Halmashauri ya **Wilaya ya Serengeti asilimia 169**. Aidha, Halmashauri ya **Wilaya ya Simanjiro** imekua ya mwisho kwa kuchangia **asilimia 3** ikifuatiwa na Halmashauri za **Wilaya ya Liwale asilimia 4** na Halmashauri ya **Wilaya ya Kishapu asilimia 13** (*Kiambatisho Na.5*)

4.0 CHANGAMOTO ZILIZOBAINIKA

Tumebaini kuwepo kwa changamoto zifuatazo:-

- a) Baadhi ya Halmashauri kutokuingiza taarifa za ukusanyaji mapato lindwa kwenye mfumo wa utoaji taarifa ya mapato na matumizi (FFARS) wa Vituo vya kutolea huduma kwa wakati hivyo, kupelekea ugumu na ucheleweshaji wa uandaaji wa taarifa hii.
- b) Baadhi ya Halmashauri kutumia vifungu visivyo sahihi vya Matumizi ya fedha za miradi ya maendeleo mfano matumizi yasiyo sahihi kwenye ulipaji wa Mikopo ya Wanawake, Vijana na Watu wenyne Ulemavu, hivyo kusababisha Halmashauri husika kuonekana haijatoa mikopo na kusababisha kutofautiana kwa taarifa kati ya OR – TAMISEMI na Halmashauri.
- c) Baadhi ya Halmashauri kutokufanya usuluhishi (*reconciliation*) wa taarifa za mapato lindwa kwenye mfumo wa Uhaisbu wa vituo vya kutolea huduma (FFARS), hivyo kuchelewesha uandaaji wa taarifa kutoka kwenye mfumo.
- d) Baadhi ya Halmashauri zimeshindwa kufikia malengo ya makusanyo ya mapato ya ndani, hivyo kuathiri utoaji wa huduma kwa jamii ikiwa ni pamoja na kutokuchangia miradi ya maendeleo na mikopo ya Wanawake, Vijana na Watu wenyne Ulemavu.
- e) Mifumo ya utoaji taarifa kutokuwa uwezo wa kutoa taarifa zinazohitajika kulingana na mahitaji. Mfano wa Mfumo wa Ulipaji Serikalini (MUSE) bado una changamoto ya utoaji wa taarifa. Hata hivyo, tunaendelea kufanya mawasiliano na Hazina ili kutatua changamoto hizi.

5.0 MIKAKATI YA KUTATUA CHANGAMOTO

- a) Ofisi ya Rais-TAMISEMI kwa kushirikiana na Sekretarieti za Mikoa zitaendelea kuhakikisha kazi ya uingizaji wa mapato pamoja na usuluhishi wa taarifa za fedha inafanyika kila mwezi ifikapo au kabla ya tarehe 15 baada ya mwezi husika kuisha.
- b) Halmashauri zitaendelea kukumbushwa kuchangia miradi ya maendeleo ikiwa ni pamoja na mikopo ya Wanawake, Vijana na Watu wenyne Ulemavu kwa mujibu

wa Sheria. Aidha, fedha hizi ziendelee kutolewa kwenye shughuli zenyе tija na zinazogusa Wananchi.

- c) Ofisi ya Rais-TAMISEMI kwa kushirikiana na Sekretarieti za Mikoa itaendelea kuzisimamia Halmashauri katika masuala ya ukusanyaji wa mapato ya ndani ikiwa ni pamoja na matumizi sahihi ya mifumo ili kuondoa mianya ya uvujaji wa mapato;
- d) Ofisi ya Rais-TAMISEMI itaendelea kuboresha mifumo ya ukusanyaji wa mapato ya ndani ili kudhibiti mianya ya upotevu wa mapato.
- e) Ofisi ya Rais-TAMISEMI inazielekeza Halmashauri kuendelea kubuni vyanzo vipyä nya mapato ikiwa ni pamoja na kuwekeza fedha za makusanyo ya ndani kwenye Miradi ya Uwekezaji kama inavyofanyika kwa baadhi ya Halmashauri mfano kwa Manispaa ya Kahama.
- f) Ofisi ya Rais-TAMISEMI inazielekeza Halmashauri kubuni Miradi ya Kilimo cha mazao ya kimkakati (kibiasara) ili kukuza Uchumi wa wananchi pamoja kuongeza makusanyo ya Halmashauri, mfano Halmashauri ya Wilaya ya Manyoni ambayo imeratibu kilimo cha zao la korosho kama sehemu ya zao mkakati.
- g) Ofisi ya Rais-TAMISEMI inazielekeza Halmashauri kuanzisha utaratibu wa kupima ardhi kwa ajili ya mashamba ya ukodishaji ili kurahisisha shughuli za kilimo na hatimaye kuwa na uwakika wa mazao ya chakula na biashara ambapo itaongeza kipato kwa Wananchi na makusanyo ya Halmashauri.
- h) Ofisi ya Rais-TAMISEMI itaendelea kuboresha mifumo ya utoaji wa taarifa ili kurahisisha upatikanaji wa taarifa sahihi na kwa wakati.

6.0 MAELEKEZO KWA MIKOA, HALMASHAURI ZA MAJIFI, MANISPAA, MIJI, NA HALMASHAURI ZA WILAYA.

(a) Maelekezo kwa Halmashauri za Majifi, Manispaa, Miji na Wilaya.

- i) Halmashauri ziimarishe usimamizi wa ukusanyaji wa mapato ya ndani ikiwa ni pamoja na matumizi ya mifumo ya kielektroniki ya ukusanyaji wa mapato ili kuondoa mianya ya uvujaji wa mapato.

- ii) Halmashauri zihakikishe kuwa fedha za makusanyo ya ndani zinazokusanywa kwa kutumia POS na zinapelekwa benki ndani ya masaa 48 badala ya kuzitumia kabla ya kupelekwa Benki.
- iii) Halmashauri zihakikishe zinapeleka **asilimia 40 au 60** ya fedha za makusanyo ya ndani kwenye miradi ya maendeleo ili kutatua kero za Wananchi zinazohusu Elimu, Afya, Miundombinu ya barabara, pamoja na Miundombinu ya kiuchumi na Uwekezaji mfano Masoko na Stendi. Kwa Halmashauri zenyе makusanyo kuanzia **Bilioni 5** na zaidi, zihakikishe zinatumia **asilimia 10** ya sehemu ya fedha zao za maendeleo kwenye uboreshaji wa Miundombinu ya barabara kupitia TARURA. Aidha, Wakurugenzi wahakikishe fedha za mapato ya ndani zinatumika kujenga miradi na kukamilika kwa **asilimia 100** ili wananchi waweze kuona faida za mapato ya ndani na hatimaye kuongeza mwamko wa ulipaji wa kodi na ushuru.
- iv) Halmashauri zihakikishe zinakamilisha miradi ambayo hajikamilika (viporo) kabla ya kuanzisha miradi mipy. Ni wajibu wa kila Halmashauri kufanya tathmini ya Miradi ambayo hajikamilika ili kuwekeza nguvu kwenye ukamilishaji wa Miradi hiyo.
- v) Wakurugenzi wa Halmashauri wahakikishe wanapeleka **asilimia 10** ya fedha za mikopo ya Vikundi vya Wanawake, Vijana na Watu wenye Ulemavu kama ilivyo idhinishwa kwenye bajeti zao. Fedha hizi zitumike kwenye shughuli zitakazoleta tija kwa Uchumi wa Wananchi na Taifa kwa ujumla.
- vi) Mabaraza ya Madiwani yahakikishe yanasmamia ipasavyo matumizi ya fedha za Halmashauri ili kupata thamani halisi ya fedha zinazotumika. Hii ni pamoja na kutembelea Miradi yote iliyoteklezwa kwa kutumia fedha za mapato ya ndani ili kujiridhisha na matumizi ya fedha hizo kama yanatatua kero za Wananchi.
- vii) Mabaraza ya Madiwani yahakikishe yanajiridhisha na matumizi ya fedha zinazotoka Serikali Kuu, mfano fedha za UVIKO 19, fedha za ujenzi wa Vituo vya Afya, Miradi ya Elimu, Fedha za EP4R, n.k.
- viii) Halmashauri zihakikishe zinalipa madeni yaliyohakikiwa ya Watumishi, Wazabuni pamoja na Watoa huduma kwa kuzingatia Sheria na Kanuni za fedha. Pia, ziandae mpangokazi wa ulipaji wa madeni hayo.

(b) Maelekezo kwa Mikoa

- i) Sekretarieti za Mikoa zifanye ufuatiliaji wa mapato na matumizi ya Halmashauri kila robo mwaka ili kujiridhisha na ukusanyaji wa mapato pamoja na matumizi na kuwasilisha taarifa za utekelezaji Ofisi ya Rais - TAMISEMI kabla ya tarehe 20 baada ya robo husika kuisha.
- ii) Sekretarieti za Mikoa zifanye ufuatiliaji wa fedha za miradi iliyopo kwenye Halmashauri zao ili kujiridhisha na ubora wa Miradi inayotekelizwa.
- iii) Sekretarieti za Mikoa zifanye uhakiki wa fedha za mapato ya ndani zilizotumika kwenye Miradi kwenye robo ya kwanza ya mwaka wa fedha 2021/22 ili kujiridhisha na Miradi iliyotekelizwa kwa kila Halmashauri na kuwasilisha taarifa ya utekelezaji Ofisi ya Rais – TAMISEMI kabla ya tarehe 29 Novemba, 2021.
- iv) Sekretarieti za Mikoa zihakikishe zinajiridhisha na matumizi ya fedha zinazotoka Serikali Kuu, mfano fedha za UVIKO 19, fedha za ujenzi wa Vituo vya Afya, Miradi ya Elimu, Fedha za EP4R, n.k.
